

About us



The British Council is the UK's international organisation for cultural relations and educational opportunities.

We build connections, understanding and trust between people in the UK and more than 100 countries across the world through arts and culture, education and the English language. It takes time to build trust. We have developed those skills over 85 years, made possible in part by our openness to working collaboratively with many partners in the UK and globally.

In Vietnam, the status of the British Council was renewed for five years by Decision 4789/QĐ-BGDĐT – dated 13 December 2019. We continue to operate as a foreign independent cultural, educational and non-profit organisation delivering programmes in culture, education, training and technical partnership programmes.

2019 was a milestone year for the British Council in Vietnam as it marked the successful completion of our operations under Decision 7269/QĐ-BGDĐT, valid for 10 years from October 2009.

Decision 4789/ QĐ-BGDĐT formally recognises the successful continuous operation of the British Council in Vietnam since 1993 as a leading authority in cultural relations, educational opportunities and English language teaching. We have successfully used the cultural resources of the UK to pursue our mission of building connections, understanding and trust in a world of opportunity.

The British Council in Vietnam has ensured full compliance with current Vietnamese laws and regulations relating to our activities within Vietnam, including programmes and financial reporting, tax contributions, professional development and job opportunities for Vietnamese, as well as our organisational commitments to child protection, equality, diversity and inclusion.

Our status

From 14 December 2019, the British Council in Vietnam consists of two entities: a) the British Council Vietnam as regulated in Decision 4789/QĐ-BGDĐT (dated 13 December 2019) operating in the fields of culture, education and technical cooperation programmes and b) the British Council Limited Liability Company (Vietnam) incorporated under Vietnam's Enterprise and Investment laws, with Enterprise registration number 0107581903, effective from 19 September 2016 delivering English language teaching, examination and educational support services.

The two entities form the British Council's operations in Vietnam with a shared purpose of building connections, understanding and trust through arts and culture, education and the English language contributing to the British Council's global vision. With the established status of the two entities, we are confident in expanding the reach and quality of our partnership

programmes, teaching and exams services to more people in Vietnam. We look forward to further strengthening and expanding our collaboration with ministries, organisations and individuals in Vietnam, in the UK and in our global network to actively contribute to the strategic partnership between Vietnam and the UK in reflecting the development priorities of both countries and continued international integration.

Aims

- Showcase the UK arts and creativity and promote collaboration between UK and Vietnamese artists.
- Create opportunities for cultural professionals and artists to develop their knowledge, artistic practice, skills and networks contributing to greater prosperity.
- Strengthen the network and connections of cultural and creative hubs in Vietnam and the UK.
- Support communities, including those with marginalised groups, to gain better access to and awareness about arts and cultural heritage as well as contribute and benefit from their cultural values.




Work with different local and international arts and creative organisations to create arts opportunities and collaboration between Vietnamese and British artists.

Results

- More than 24,000 people from communities of heritage bearers in Gia Lai, Kontum, Ninh Thuan and Ho Chi Minh City have been involved in a series of music transmissions/concerts, research, capacity building and festivals across the year.
- Grants to support 25 projects that engage with the music and/or film heritage of Vietnam.
- 273 cultural organisations engaged in the Cultural and Creative Hubs Vietnam project.
- A symposium and a policy dialogue provided connections between 118 cultural hub owners and representatives from the National Assembly and Hanoi Cultural Administration.

- In partnership with Kim Dong publishing house, to showcase British graphic books through a reading workshop on favourite British children's authors and a three-month exhibition introducing British contemporary graphic novelists.
- As part of our ongoing partnership with Monsoon Music Festival, the first international outdoor music festival in Vietnam, we joined its fifth edition through supporting the curator of The Great Escape Festival (Brighton UK) to take part in a conference series discussing key music industry themes.





The project [Beautiful and Real: An Oral History of Cai Luong, as part of Cultural Heritage for Inclusive Growth] aimed to use oral history and public heritage to support economic and social development through providing arts communities with a sense of identity, history and heritage. It also aimed to contribute to new Anglo-Vietnamese research conversations and unprecedented levels of trust, shared exchange and engagement within 'hard to reach' communities. The project was exceptionally well managed and prepared by the British Council team in Vietnam. Every aspect planned as part of the Oral History research team was achieved and we enjoyed collaborating and working together.












5. Can Tho University – Impact Assessment Results






7. Mien Tay Construction University - Impact Assessment Results

Aims

Managed by the Department of Business, Energy and Industry Strategy (BEIS), the Newton Fund, with total UK Government investment of GBP735 million up until 2021 with matched resources from partner countries, aims to:



Research and insight - Commissioning research and publishing insights

- EME Consultancy into 'The growing global phenomenon of English Medium Education (EME) in higher education: policy, perceptions, impact and the role of 'English' explores questions such as 'What does the spread of EME mean for educational policy as well as university teaching staff?' and also 'What do staff and students feel about the use of EME?' Insights from this research will be disseminated to Ministry of Education and Training, universities and other relevant stakeholders during 2020.
- Accreditation Consultancies to develop systems for the accreditation of in-service English language teacher education providers and an accreditation framework for English language centres, incorporating standards, criteria, indicators and relevant evidence. These accreditation frameworks will help the Ministry of Education and Training manage ELT quality standards and service providers to better meet the needs of learners in Vietnam.

Stakeholder engagement – Working with key partners

- Teaching and Learning foreign languages in the National Education System
 Project In January 2019, we signed a five-year partnership agreement to improve teaching and training capacity, assessment, accreditation and technology application in English language teaching.
- Provincial Departments of Education and Training – We continued and expanded our successful ongoing collaborations with Bac Giang, Can Tho, Nam Dinh and Vinh Phuc to design and deliver effective teacher development programmes using our Teaching for Success approach, which in turn helps improve student learning outcomes.

Capacity building and Continuing professional development (CPD) – Teaching for Success

- Teacher development More than 300 English teachers from Bac Giang, Can Tho, Nam Dinh and Vinh Phuc developed teaching and language skills, studied new methods, approaches and techniques. As a result, teachers are able to deliver more learnercentred and communicative lessons to help their students to become more motivated and engaged in English classes.
- Provincial teacher educators and mentors – 83 key English teachers in Bac Giang and Nam Dinh were trained by British Council trainers to become teacher educators and mentors. Having learnt new skills in designing and delivering teacher development workshops and supporting other key teachers, they will actively engage and contribute to the continuing professional development of teachers in their provinces.
- National teacher educators In response to the Teaching and Learning foreign languages in the National Education System Project needs, content for a 150-hour teacher educator programme for 10 key teacher training universities was developed. The content will be blended, with more than 40 hours of online content to supplement face to face training. The target audience of 200 lecturers will go on to provide teacher development training for primary, lower- and upper-secondary teachers of English across all 63 provinces with the aim of encouraging them to apply more learner-centred approaches to their teaching, in line with the Ministry of Education and Training's goal to improve the teaching and learning of English.
- EME in universities Increasing numbers of universities in Vietnam are delivering subjects as diverse as finance, economics, law and engineering through English as the Medium of Education (EME). In order to build capacity amongst university leaders and academic staff, we have provided a series of 30-90-hour Academic Teaching Excellence (ATE) training events, focusing on the effective delivery of subject-specific content at tertiary level. Since 2015, more than 390 lecturers from 85 universities and colleges across the country have taken part. In 2019, we worked with Ho Chi Minh City University of Technology and Hanoi University of Industry.



More about our programmes

IELTS Prize 18/19

In August 2019, the British Council IELTS Prize was awarded to three outstanding IELTS test-takers in Vietnam with prize values of VND180 million, VND150 million and VND120 million for first, second and third prizes to three excellent IELTS test-takers in Vietnam (Nguyen Duc Thinh, Vo Tan Thuan and Truong Minh Hang, respectively).

Since its launch in 2011, the British Council IELTS prize has supported more than 270 students in East Asia to pursue their dreams of studying abroad. During 2018–19, the British Council interviewed more than 100 exceptional individuals who excelled in their IELTS tests and showed admirable determination to contribute to society, locally or abroad.

Vietnam Language Assessment Symposium (VLAS), November 2019

In November 2019, in cooperation with Vietnam National Foreign Languages Project (Ministry of Education and Training) and British University Vietnam (BUV) we organised the second VLAS (Vietnam Language Assessment Symposium) in Hanoi at the British University Vietnam. This involved more than 200 English specialist participants from city/provincial Departments of Education and Training, universities, colleges, upper-secondary schools and foreign language centres in Hanoi and across Vietnam,

participating in plenary sessions and panel discussions focusing on establishing the connection between teaching, learning and assessment - from formative assessment to high-stakes tests.

Examinations and teacher training programmes delivered in 2019–20

We also provided continuing professional development to almost 500 teachers directly and virtually to support Vietnamese teachers in assessments of literacy and teaching methodology in preparing students for the Aptis and IELTS tests.

As forums to exchange research findings, ideas, resources and methods of English language assessment for researchers, practitioners and teachers, VLAS 2019 succeeded in strengthening the English assessment networks to respond to new English teaching and learning trends in modern times. We could say that conferences like this one have made great contributions to the implementation of Vietnam's Foreign language teaching and learning in the national education system project.

Personnel

As of 31 March 2020, the British Council employed a total of 280 staff at its main Hanoi office and its branch in Ho Chi Minh City, including two UK-appointed staff, 169 local staff and 109 foreign staff (mainly teaching staff).

Throughout its presence and across its operations in Vietnam, the British Council maintains a strong and consistent commitment to full compliance with the local regulations regarding the selection, appointment and management of its staff.

For all foreign staff who are recruited or appointed to work in Vietnam, their applications for visa and work permits are compliant with local regulations on foreign employees. All statutory contributions to social funds (social insurance, medical insurance, unemployment insurance) for local and foreign staff are made in line with current laws.

The British Council also ensures that the tax liabilities of staff are correctly and promptly calculated, withheld and paid to the State budget,

as endorsed by the Hanoi and Ho Chi Minh City Departments of Taxation.

We are committed to continuous professional development for our staff, investing in a range of learning and development programmes to support the achievement of the British Council's strategic goals, to help staff perform well in their current roles, support their career development and enhance their longer-term capability and contribution to wider society.



Equality, Diversity and Inclusion

Our Equality Policy and Equality, Diversity and Inclusion (EDI) Strategy sets out how we approach the challenges of mainstreaming equality, diversity and inclusion internationally, ensuring that EDI is central to all our programmes, projects, services as well as internal procedures and ways of working. We have developed a range of organisation-wide tools and initiatives to help us build diversity into our work.

The Diversity Assessment Framework is our overarching diversity measurement tool. It is used worldwide to assess the progress our business areas, country offices, and regional teams are making in mainstreaming diversity. It contains a series of indicators that help measure performance across important areas. All parts of the organisation submit evidence of action taken against these indicators which is centrally reviewed and assessed and given a score, plus a detailed report. The report helps us measure our progress in equality, diversity and inclusion as an organisation.

In Vietnam, we have achieved a very positive result in the Diversity Assessment Framework for the period 2018–2020 – a score of 8/10, exceeding in three indicators, including leadership and developing a comprehensive approach to making adjustments across our offices in Vietnam to respond to the needs of those with different abilities.

We designed and delivered a series of activities with our staff as well as mainstreaming into all of our programme and activities with stakeholders to raise awareness about EDI. This included organising various team-building and social activities, involving traditional dress festivals, fruit carving and decoration competitions ensuring gender-balanced teams to encourage male engagement in a popular Vietnamese activity usually led by women. In order to deepen understanding of all colleagues on three EDI themes of Racism, Gender and Disability and to maximise impact of our activities, we successfully delivered a diverse series of activities over three months (October, November and December 2019) including EDI quizzes, sign language training for staff and our 'journeys through food' events that created more space for cultural exchanges, interactions between staff who normally would not work directly together, and more importantly to celebrate the diverse culture of the office with colleagues from more than 15 countries sharing their national and regional dishes with recipes and background stories. We look forward to further mainstreaming EDI across our work in Vietnam in the coming years.






Diversity Assessment Framework

Child Protection

Our commitment to Child Protection

The British Council believes all children have potential and that every child matters - everywhere in the world. Protecting children from abuse is at the heart of our organisational values and we take our duty of care towards children extremely seriously as reflected in our zero tolerance child protection policy, in line with article 19, UNCRC, 1989. We are committed to child safeguarding and exceeding international standards on keeping children safe. Developing good practice across the diverse and complex areas in which we operate and increasing our accountability in our work with children are central to our mission to be a child safe organisation.

We ensure that appropriate child protection policies and procedures are designed and implemented for all British Council activities in Vietnam, including safe collection policies for young learners, test-day operational policies for examinations and project activity planning and delivery documents and policies. We guarantee that Teaching Centre students under the age of 11 can only leave with parents or designated guardians and give clear guidance to students on internet safety.

Before any event involving children/young learners, we conduct risk assessments and checklists for child safety and ensure that every member of staff undertakes regular child protection training so we provide a safe environment for children, making clear our commitment to child protection in our work with partners.

We have developed a Child Safe Action Plan involving representatives from all our teams and centres, we use this detailed tool to regularly assess and review all our work with children across all programmes and services to ensure all reasonable measures are taken to protect children from harm. In addition, audits and reviews are undertaken by external child protection experts to ensure we adhere to the required standards of excellence and good practice and that the British Council corporate policy updates and other legal standards are promptly and comprehensively applied in Vietnam. Since 2016-17 we have applied safer recruitment to ensure only staff suitable to work with children are recruited for posts that require direct contact with children, or manage staff working with children.


