## 1) Introduction

and investment in the education sector. The Ministry of Education and Training - Department of International Cooperation, an arm of government advisory, monitoring and delivery services in this area, has recently reviewed and consulted with various related ministries, including the Ministry of Planning and Investment, as well as principal education stakeholders, to develop guidelines related to the regulatory framework. This is intended to build potential international investor and partner confidence, and support decisionmaking on registration and operation in this strictly regulated area.

This guidebook therefore contextualises and interprets the regulatory framework applicable to foreign cooperation and investment in education and training in pre-school, school and higher education sectors, with focus on Decree 86 (2018) and Decree 99 (2019), with the exception of technical and vocational education and training (TVET).

## 2) Education landscape

### Overview

The education system in Viet Nam has five levels: pre-school, primary school (Grades 1-5), secondary school (Grades 6-9), high school (Grades 10-12), and tertiary education, which includes vocational training and higher education.

The Ministry of Education and Training (MOET) has been the highest state management agency for Viet Nam's education from P-12 to higher education and teacher education. At the same time, TVET has come under the jurisdiction of the Ministry of Labour, War Invalids and Social Affairs (MOLISA). The administrative structure of education is multi-tiered. At the central level, MOET is the policy-making body in education, governing lower-level education functional bodies, including provincial departments of education and training (DOETs). DOETs are responsible for district-level bureaus of education and training (BOETs). DOETs and BOETs are subject to administrative management of provincial and district-level people's committees.

Regarding higher education, MOET exercises its state management functions over all higher education institutions and administrative functions over institutions directly under MOET (35 universities and 3 teacher training colleges). Other ministries, often known as 'line ministries', and provincial authorities exercise administrative functions over their higher education institutions.

Education in Viet Nam has always been the top national policy. Investment in education is considered investment in development. Since 1986, when Viet Nam began the renovation often known as 'đổi mới', a number of policies have been issued to boost education development. One of the key policies has been the Central Party's Resolution No. 29 on comprehensive and fundamental reform of the education sector. The Resolution, followed by a number of other legal guiding documents, outlined nine groups of measures, including promotion of socialisation and global integration, which provide a number of incentives for foreign investment and cooperation in education. The Resolution expressly specifies promotion of socialisation in education, especially in vocational and higher education, and encourages partnerships by Vietnamese institutions with reputable foreign education institutions. With the aspiration and expectation of the Vietnamese Government for the development of education, there is ample room for investment and cooperation by foreign individuals and institutions in the years to come.

### Foreign cooperation and investment in education

#### 2.2.1. Foreign direct investment

According to the Foreign Investment Agency of the Ministry of Planning and Investment, from 01 January 1988 to 31 June 2022, foreign direct investment in education has attracted 605 projects from 33 countries with the registered investment capital amounting to over 4.5 billion USD.




Figure 1: Number of FDI projects in education (country-wise) Source: Ministry of Planning and Investment

These foreign direct investment projects concentrate in big cities of Ho Chi Minh and Hanoi, which accounts for 91.23% of the total registered investment capital of the whole country.









Figure 2: Number of FDI projects in education (location-wise) Source: Ministry of Planning and Investment

As of 31 December 2021, there are five foreign invested universities (1.3%), 66 foreign invested pre-schools (17%) and 112 schools (28,9%), and 205 foreign invested short training institutions (52.8%), operating in 17 out of 63 provinces and distributed as in the table below.

3,022 children, of which 1,277 are Vietnamese, are learning in foreign invested pre-schools, accounting for 0.025% of the total number of children currently learning in pre-schools.

24,227 school pupils are studying in 112 foreign invested schools (primary, middle and high schools), accounting for 0.14% of total school pupils of the whole country.

13,008 students are studying in five foreign invested universities, accounting for 0.68% of the total number of students in Viet Nam.


There are 63,145 students learning in 205 foreign invested short-term training institutions located mainly in Ho Chi Minh City (98, or 47,8%), Hanoi (67, or 32,7%), and Da Nang (14, or 6.8%). These short-term training institutions mainly provide language training in English (76 institutions), Japanese, Korean, French, and office, accounting, marketing and business skills.

The school tuition fee of these foreign invested schools ranges from 420 to 767 million Dong per year. The foreign invested university tuition fee ranges from 400 to 600 million Dong per year.

#### 2.2.2. Joint education and training

As of 31 June 2022, 40 joint education programmes have been approved, of which 23 programmes are in Hanoi, ten in Ho Chi Minh City, three in Da Nang and one programme in Khanh Hoa, Quang Ninh, Quang Nam and Hai Phong respectively.




#### **Figure 5: Number of joint education programmes** Source: Ministry of Education and Training

The integrated curriculum and double certificates mainly come from the UK (the Cambridge curriculum, A level), International Baccalaureate, Australia, Finland and the US. The extra fee for the students of these joint education programmes ranges from 6.5 to 14 million Dong per month.

As of 31 December 2021, there are 408 joint training programmes, of which 186 programmes are approved by autonomous universities, 222 programmes are approved by MOET. 85 Vietnamese higher education institutions have partnered with universities in 26 countries. The UK is the top country with 101 programmes.


#### Figure 6: Distribution of joint training programmes (country-wise) Source: Ministry of Education and Training

Out of 408 joint training programmes, there are 282 undergraduate programmes (69.1%), 106 masters programmes (26%) and 20 doctorate programmes (4.9%). Programmes in economics and business account for 64%, science and engineering 25%, social science and humanities 8% and 3% for others.

#### 2.2.3 Representative offices

As of 31 June 2022, 26 representative offices from 13 countries have been set up, of which five offices have terminated operations due to the Covid pandemic.




Figure 9: Total number of representative offices of foreign education institutions (country-wise). Source: Ministry of Education and Training.



3) Opportunities and Challenges

#### **3.1. Opportunities**

The Government of Viet Nam issued Resolution No. 35/NQ-CP on 4 June 2019 on increasing mobilisation of social resources for investment in education development for the period 2019-2025. The Government has set clear targets to raise the percentage of students studying in private institutions from 6% in 2019 to 16% in 2025, and in particular university students from 13.8% in 2019 to 22.5% in 2025.

To reach these targets of students in private education institutions, the Government has also set a target of establishing new private institutions to increase from 6.68% in 2019 to 13.5% in 2025.

The opportunities are open not only for Vietnamese investors but also for foreign investors to engage in the development of the education sector when the demand for quality education is very high. especially in the process of industrialisation, modernisation and global integration of Viet Nam.

The Government of Viet Nam, being fully aware of the needs for the internationalisation of education, issued a legal framework as early as 2000 for foreign investment in Viet Nam. Over the years, the regulations have been revised two times, resulting in the most recent Decree No. 86/2018/ND-CP on foreign investment and cooperation in education and training, which is now under revision to better accommodate real-life practice.

Decree 86 provides regulations on the establishment and operation of foreign invested institutions, including short-term training institutions, pre-schools, schools and universities; the establishment and operation of joint education/training programmes; and the establishment of representative offices.

Detailed guidance will be presented in the following section.



#### 3.2. Challenges

The opportunities are open and readily available for any investor to grasp but there are always challenges for those investors to confront. The first challenge is to understand the legal framework and that is one of the reasons for the preparation of this guide. When investing in a foreign-invested education institution, either 100 percent foreign owned capital or in partnership with local investors, there are other legal documents to observe, such

as those on Investment Law, Enterprise Law, and so on. The second challenge is to find an appropriate local partner, one who really can deliver the right level of commitment for joint education or training programmes or other joint ventures. The third challenge is quality assurance, once an institution or programme has been set up. Quality control is crucial to ensure sustainable growth and to guarantee the long-term interests of all parties.







## 4) Approval process rocess

Approval process for the establishment of a joint education program (school sector)



#### **APPLICATION FOR APPROVAL** OF AN INTEGRATED PROGRAM

Eligibility: Vietnamese private pre-schools and schools, and foreign legally accredited education institutions.

#### **Conditions:**

1. Curriculum: Foreign curricula to be integrated must be accredited in their home countries by competent agencies.

2. The integrated curriculum must meet the objectives of the Vietnamese curriculum while maintaining the requirements of the foreign curriculum; not requiring the students to learn the same content, ensuring consistency and stability throughout the class level and connections between levels for the benefits of students with voluntary participation and avoiding learning overload.

3. The integrated curriculum must be approved by the Minister of Education and Training.

4. The scale and physical facilities must meet the requirements of the integrated curriculum without affecting the general teaching and learning of the Vietnamese partner.

5. Teachers involved in delivering the integrated curriculum must meet current regulations.

#### **Essential documents required:**

1. An application for approval of the integrated curriculum.

2. Foreign curriculum with contents and subjects to be integrated and the integrated curriculum proposed to be delivered.

3. Documents explaining the integration of the curriculum.

4. A certificate of accreditation or an approval of the foreign curriculum by a competent agency (a certified true copy or a copy enclosed with an original).

#### Procedures:

1. One set of the documents listed above is submitted to DOET by hand or by post; DOET will then submit to MOET.

2. Within 20 working days upon receipt of complete documents, MOET will appraise the integrated curriculum and notify DOET.

3. If the documents are incomplete, within five working days MOET will notify DOET in writing by post or email.

#### Licensing authority

MOET

#### Approval duration

A decision will be issued within twenty (20) working days from the date the complete application is received.



#### **APPLICATION FOR APPROVAL OF** A JOINT EDUCATION PROGRAM

#### **Essential documents required:**

1. An application for approval of the joint education programme signed by all parties.

2. A cooperation agreement or contract between the partners, specifying the information of the partners, responsibilities of the partners' commitments on the curriculum, learning and teaching materials, teaching staff, physical facilities, testing and assessment, financial information and other details.

3. Documents proving the legal status of both parties, including: a certified true copy, or a copy enclosed with an original, of the decision of establishment or the establishment licence granted to the educational institution; or other equivalent documents.

4. Foreign curriculum with contents and subjects to be integrated and the integrated curriculum proposed to be delivered.

5. Documents explaining the integration of the integrated curriculum.

6. A certificate of accreditation or an approval of the foreign curriculum by a competent agency (a certified true copy or a copy enclosed with an original).

7. The proposal of joint education developed by both partners.





#### Procedures:

1. One set of the documents listed above is submitted to DOET by hand or by post.

2. Within ten working days upon receipt of complete documents, DOET will submit to MOET for approval of the integrated curriculum.

3. If the documents are incomplete DOET will notify the applicant in writing.

4. Within five working days upon receipt of the appraisal of the integrated curriculum by MOET. DOET will issue a decision for the joint education programme. In the event of rejection, DOET will notify the applicant, specifying clearly the reasons for rejection.

#### Licensing authority

MOET

#### Validity period

The decision validity period is five years from the date of issuance and renewable for five-year periods.

#### **Reporting scheme**

Annual reports by institutions are to be submitted DOET by 31 October every year.

## 



#### **RENEWALS OR MODIFICATIONS OF** JOINT EDUCATION PROGRAMMES

Approvals of joint education programmes are valid only for five years. The parties must renew the licence six months before it expires.

#### Conditions for renewals:

1. The parties to the joint education programmes have strictly complied with the licence granted.

2. No breaches of Vietnamese and/or foreign laws have been committed.

#### Essential documents required for renewals or modifications of the licence:

1. An application for renewal or modification of the joint education programme signed by both partners.

2. A report reviewing the joint education operations during the licenced period.

3. An effective cooperation agreement or contract between the partners, specifying the information of the partners, responsibilities of the partners' commitments on the curriculum, learning and teaching materials, teaching staff, physical facilities, testing and assessment, financial information and other details.

#### Procedures:

1. One set of the documents listed above is submitted to DOET by hand or by post.

2. If the documents are incomplete DOET will notify the applicant in writing by post or email within five working days.

3. Within ten working days upon receipt of complete documents, DOET will appraise the application documents and issue a decision of renewal or modification of the licence. In the event of rejection, DOET will notify the applicant, specifying clearly the reasons for rejection.





SUSPENSION OF RECRUITMENT OR

Recruitment of students is suspended if any of the conditions required for the approval of the joint education programme is not met.

Where recruitment of students is suspended, the partners are responsible for:

1. Remedies of the breaches leading to the suspension of recruitment.

2. The continuation of study by current students of the joint education programme.

3. Submission of a report to the licensing authority of the remedies for the suspension for approval of continued recruitment.

#### The operation of a joint education programme is terminated in the following cases:

1. Upon the expiry of the licence or the renewed or modified licence.

2. Upon the request of the parties to the joint education programme.

3. The period of recruitment suspension expires but the breaches resulting in the suspension are not overcome.

4. Breaches of the licence or renewed licence to the extent required by the laws that the operation must be terminated.



### TERMINATION OF JOINT EDUCATION PROGRAMMES

#### In case of early termination of a joint education programme, the partners are responsible for:

1. Ensuring continuation of study by the students of the joint education programme until they finish the school level.

2. Reimbursement of all the money paid by the students.

3. Payment of salaries, wages, teaching remuneration and other benefits for teachers and employees subject to their labour contracts or collective labour agreements in compliance with the labour code. 4. Payment of outstanding taxes (if any) and other liabilities.

#### **Essential document required:**

An application for termination of a joint education programme, clearly specifying the reasons for termination; a plan for termination; measures to protect the legal rights of learners and workers; a plan for financial and asset resolution.

#### Procedures:

1. One set of the documents listed above is submitted to the competent licensing authority. 2. Within 15 working days upon receipt of the complete document, the document receiving agency will appraise the document, make a decision of termination of the joint education programme, and publicise the decision via mass media.

4.2

#### Approval process for the establishment of a joint training program (HE sector)

#### **Eligibility:**

Vietnamese and foreign higher education institutions must be legally established, accredited and currently operating legally in their home countries.

#### Modes of delivery:

- 1. In-person
- 2. Online
- 3. Hybrid

#### **Conditions:**

1. Eligible Vietnamese and foreign higher education institutions can only cooperate to provide joint training programmes within the training disciplines and levels permitted by their home country's competent authorities.

2. The joint training scale is determined based on quality assurance conditions, including physical facilities and human resources, which are not to be used in calculation of the total recruitment quota of the higher education institution.

3. Students recruited for Vietnamese qualifications must satisfy the current Vietnamese regulations on enrolment conditions of the respective training level. Students recruited for foreign qualifications must satisfy the current foreign regulations on enrolment conditions of the respective training level of the foreign partner's home country. Students recruited for both Vietnamese and foreign qualifications must satisfy the current Vietnamese and foreign regulations on enrolment conditions of the respective training level.

4. Foreign language proficiency requirement: Joint training programmes must be delivered in a foreign language if foreign qualifications are to be awarded. Students recruited for Vietnamese qualifications must have at least level 3 proficiency (B1 in CEFR) in the Vietnamese National Foreign Language Proficiency Framework, or equivalent. Students recruited for foreign qualifications or both Vietnamese and foreign qualifications must have at least level 4 proficiency (B2 in CEFR) in the



Vietnamese National Foreign Language Proficiency Framework, or equivalent.

5. Training curriculum: Joint training programmes may adopt foreign curricula or curricula jointly developed by the parties to the joint training programmes and can be fully delivered in Viet Nam or partially in Viet Nam and partially overseas, leading to Vietnamese or foreign awards or both Vietnamese and foreign awards. The foreign curriculum to be delivered in Viet Nam must be accredited in the foreign partner's home country or the training quality is recognised by a competent agency of the foreign partner's home country. The training curriculum must not contain contents and subjects that damage national defence and security, and/or public interests; propagate religion; distort history; or negatively affect the culture, ethics and traditional customs of Viet Nam. The training curriculum must ensure connecting pathways between training levels.

6. Joint training outcome standards must not be lower than those as prescribed by Vietnamese regulations.

7. Physical facilities: Physical facilities used for joint training programmes must be appropriate with the training discipline, without affecting the general teaching and learning of the Vietnamese institution. The average area used for face-to-face joint training programmes must be at least 5m<sup>2</sup> per student. Students of joint training programmes must be supplied with adequate learning resources for their

study and research. Joint training programmes must not be conducted outside the main campus of the Vietnamese partner institution.

#### 8. Academics:

a.Lecturers of joint training programmes must have higher education teaching experience.

b. Lecturers teaching in a foreign language must meet the foreign language proficiency requirements of the joint training programme, but not lower than level 5 (C1 in CEFR) in the Vietnamese National Foreign Language Proficiency Framework, or equivalent.

c. Native language teachers teaching foreign language skills must hold at least bachelors' degrees and appropriate language teaching certificates.

d. For undergraduate joint training programmes: Lecturers must hold at least masters' degrees of appropriate specialisation.

e. For masters' joint training programmes: Lecturers must have doctorate degrees with appropriate specialisation. Lecturers in charge of practical training may have masters' degrees of suitable specialisation.

f. For doctorate joint training programmes: Teaching lecturers must have doctorate degrees of suitable specialisation. Supervisors must meet minimum requirements as stipulated for Vietnamese doctorate training.



#### Quality assurance of joint training programmes

#### EXAMS AND ASSESSMENT:

Examinations, assessment and certificates of subject completion and training programmes and graduation recognition must comply with Vietnamese law when awarding Vietnamese qualifications, or comply with foreign laws when awarding foreign qualifications. Exams and assessments for online subjects must be conducted offline at the Vietnamese partner's premises.

#### QUALIFICATIONS

1. Qualifications to be awarded by Vietnamese institutions must comply with current Vietnamese regulations.

2. Qualifications to be awarded by foreign institutions must comply with relevant foreign regulations and be accepted by relevant Vietnamese authorities.

3. Where qualifications are to be awarded by both partners, compliance with relevant regulations of their home countries must be met by both partners.



#### **APPLICATION FOR APPROVAL** OF A JOINT TRAINING PROGRAM

#### **Essential documents required:**

1. An application for approval of the joint training Essential documents required:

1. An application for approval of the joint training programme signed by both partners.

2. A cooperation agreement or contract between the partners, specifying information about the partners, responsibilities of the partners' commitments on the curriculum, learning and teaching materials, teaching staff, physical facilities, testing and assessment, financial information and other details.

3. Documents proving the legal status of both partners: a certified true copy, or a copy enclosed with an original, of the establishment decision or the establishment licence granted to the educational institutions; or other equivalent documents.

4. Documents proving that both Vietnamese educational institutions and foreign educational institutions are permitted to provide training in the proposed field of joint training (a certified true copy or a copy enclosed with an original).

5. A certificate of accreditation of the foreign curriculum or documents on recognition of the education quality by a competent agency (a certified true copy or a copy enclosed with an original).

6. A written approval of the joint training programme to be conducted with a foreign partner from the superior body (line ministry), which is applicable to the Vietnamese educational institution (if any).

7. The project proposal for the joint training developed by both partners to include: necessity; objectives of the joint training programme; introduction of both parties; contents of the joint training programme; discipline and level of training; facilities, equipment and teaching contents; list of expected lecturers enclosed with their resumes; recruitment criteria; training scale; forms of examination and assessment; gualifications expected; equivalence between the foreign certificates and Vietnamese certificates; measures for education quality assurance and benefits of learners and employees; management staff: CVs of Vietnamese and foreign representative managing the programme; tuition and financial support from Vietnamese and foreign entities (if any); budget estimates; financial management mechanism; responsibilities and entitlements of both parties; responsibilities and entitlements of teachers and learners.

#### Procedures:

One set of the documents listed above is submitted by hand or by post to the competent licensing authority.

1. Within 20 working days upon receipt of the complete documents, the application receiving agency will appraise the documents and issue an approval of the joint training programme.

2. If the documents are incomplete, within five working days the application receiving agency will notify the applicant by writing either directly or by post or by email.

#### Licensing authorities

MOET for all universities and modes of delivery (in-person, online, hybrid), with the exception of the following cases:

National, regional and autonomous universities are authorised to license in-person (offline) mode of delivery of their member institutions.

#### **Approval duration**

A decision will be issued within twenty (20) working days from the date the complete application is received.

#### Validity period

The decision validity period is five years from the date of issuance and renewable for five-year periods.

#### Reporting scheme

Annual reports are to be submitted to MOET by institutions by 30 November every year.





#### EXTENSION OR AMENDMENTS OF JOINT TRAINING PROGRAMME APPROVALS

#### **Essential documents required:**

1. An application for extension of or modification to the Approval Decision signed by both parties.

2. A final report on the operation of the joint training programme within the permitted period.

3. An effective agreement or an effective cooperation contract signed by both parties.



#### **Procedures:**

One set of the documents listed above is submitted by hand or by post to the competent licensing authority.

1. Within ten working days upon receipt of complete documents, the application receiving agency will appraise the documents and issue an extension or modification approval of the joint training programme.



#### SUSPENSION OF RECRUITMENT AND TERMINATION

Recruitment of students for a joint training programme is suspended if any of the conditions required for the approval of the joint training programme is not met.

Where recruitment of students is suspended, the partners are responsible for:

1. Remedies of the breaches leading to the suspension of recruitment.

2. The continuation of study by current students of the joint training programme.

3. Submission of a report to the licensing authority of the remedies for the suspension for approval of continued recruitment.

The operation of a joint training programme is terminated in the following cases:

1. Upon the expiry of the licence or the renewal or modified licence.

2. Upon the request of the parties to the joint training programme.

3. The period of recruitment suspension expires but the breaches resulting in the suspension are not overcome.

4. Breaches of the licence or renewed or modified licence to the extent required by law that the operation must be terminated.

5. Breaches resulting in the joint training programme suspension are not overcome so as to satisfy the conditions required for the joint training programme.

In the event of termination subject to the last three points above, the partners are responsible for:

1. Transferring recruited students to other institutions:

2. Reimbursement of the money already paid by the learners if the delivery of the joint training programme and issuance of gualifications are not accepted by the Ministry of Education and Training, or the learners cannot be transferred to other institutions, or do not wish to be transferred.

3. Payment of remunerations and other benefits to teaching staff and other staff subject to their labour or collective labour contracts.

4. Payment of outstanding taxes (if any) and other liabilities.

#### **Essential document required:**

An application for termination of a joint education programme, clearly specifying the reasons for termination; a plan for termination; measures to protect the legal rights of learners and workers; a plan for financial and asset resolution.

#### Procedures:

The document listed above is submitted to the competent licensing authority.

Within 15 working days upon receipt of the complete document, the document receiving agency will appraise the document, make a decision of termination of the joint education programme, and publicise the decision via mass media.

## institution in Vietnam



#### APPLICATION FOR THE INVESTMENT LICENCE

#### Licensing Authority:

Department of Planning and Investment (DPI)

An application for an investment licence is submitted to the Department of Planning and Investment (DPI) where the proposed institution is located, which will review the application then consult with the Department of Education and Training. All these procedures are subject to the Investment Law of Viet Nam.

#### Educational conditions for issuance of the investment licence:

1. The short-term training institution proposed to be established must conform with the education institution network approved by a competent authority.

2. Investment in education must comply with the laws of Viet Nam and international treaties to which Viet Nam is a signatory.

3. Investment can be made in the disciplines subject to current regulations, except those in national defence and security, politics and religion.

#### Conditions for establishment of a foreign invested short-term training institution

#### 1. Investment capital

Minimum of 20 million VND per student (excluding land use cost). Total minimum investment is calculated at the time of fullest capacity.

For institutions renting facilities, the minimum investment per student is 14 million VND.



#### 2. Facilities

1. Classrooms with appropriate lighting, desks, chairs, and teaching equipment and materials.

2. The minimum average area for teaching is 2.5m2 per student.

3. Offices for board of directors and teachers, libraries and other functional rooms.

#### 3. Curriculum

1. The curriculum to be delivered at a foreigninvested educational institution must demonstrate educational goals, having no contents that: damage Vietnamese national defence, security and public interests; propagate religion, distort history or negatively affect the cultures, ethics and traditional customs of Viet Nam; and must ensure connecting pathways between training levels.

2. Foreign-invested institutions may adopt Vietnamese curricula according to Vietnamese laws, or foreign curricula.

#### 4. Academics

1. Teachers must hold at least bằng cao đẳng (associate degrees, or higher national diplomas), or equivalent with appropriate specialisation in the subjects to be taught.

2. The maximum converted ratio of students to teachers is 25 to 1.

1. Within 20 working days upon receipt of complete documents, the application receiving agency will take the lead in coordination with relevant agencies and units to appraise the required conditions and submit an appraisal report to the DOET director for consideration and approval of the operating licence

2. If the documents are incomplete, within five working days, the application receiving agency will notify the applicant by writing either directly or by post or by email

#### SUSPENSION AND TERMINATION **OF OPERATIONS**

#### Authority:

Department of Education and Training (DOET)

#### 1. Suspension of operation

Operations of a foreign-invested short-term training institution are suspended if committing one of these following breaches:

1. Committing fraud in order to get approval for the establishment or operation.

2. Failure to meet one of the conditions specified in Decree 86 to get approval for the operation.

3. The approval of the operating licence is granted by an unauthorised person.

4. Breaches of education regulations leading to administrative penalties to the extent that the operation must be suspended.

5. Other cases, subject to the laws of Viet Nam.

The institution may resume operations when all the breaches for the resultant operation suspension have been resolved.

The application document to resume operations includes:

1. An application for operation resumption, specifying the results of dealing with the breaches for the resultant suspension.

2. Decision of the inspection team formation.

3. The minutes of the inspection.

#### **Procedures:**

One set of the documents listed above is submitted by hand or by post to DOET.

1. Within 20 working days upon receipt of complete documents, the application receiving agency will organise the appraisal of the documents and submit the appraisal report to the DOET director for consideration and approval of resumption of operations.

2. If the documents are incomplete, within five working days, the application receiving agency will notify the applicant by writing either directly or by post or by email.

3. If the institution lacks appropriate conditions for resuming operations, within five working days upon receipt of the opinion of the DOET director, the application receiving agency will notify the applicant in writing, specifying clearly the reasons for rejection.

#### 2. Dissolution and termination of operation

A foreign-invested short term training institution is dissolved and its operation is terminated in the following cases:

1. Upon request by the investor.

2. Serious breaches of the laws or regulations on the organisation and operation of the institution.

3. The deadline to rectify the breaches of the resultant suspension as specified in the suspension decision has elapsed but causes leading to the suspension have not been overcome.

4. The goals and contents of operations specified in the operating licence are no longer in line with the country's socio-economic development.

#### Documents for dissolution and termination of operation

1. An application for dissolution and termination of operation of the institution.

2. The plan to dissolve and terminate operations of the institution, clearly specifying measures to ensure legal benefits of learners, teachers, managers and employees; a plan for the resolution of financial and asset matters.



#### **Procedures:**

One set of the documents listed above is submitted by hand or by post to DOET.

1. Within 30 working days upon receipt of complete documents, the application receiving agency will take the lead in coordination with other agencies and units to organise the appraisal of the documents and submit the appraisal report to the DOET director for consideration and approval.



2. If the documents fail to meet the requirements as prescribed, within five working days, the application receiving agency will notify the applicant by writing either directly or by post or by email.

3. Where the institution is in breach of regulations, DOET will check and inspect the breaches and make appropriate decisions.

#### **APPLICATION FOR THE INVESTMENT LICENCE**

#### Licensing authority:

Department of Planning and Investment (DPI)

An application for an investment licence is submitted to the Department of Planning and Investment where the proposed pre-school is located, which will review the application then consult with the Department of Education and Training. All these procedures are subject to the Investment Law of Viet Nam.

#### Educational conditions for issuance of the investment licence:

1. The pre-school proposed to be established must conform with the education institution network approved by a competent authority.

2. Investment in education must comply with the laws of Viet Nam and international treaties to which Viet Nam is a signatory.

3. Investment can be made in the disciplines, subject to current regulations, with the exception of those in national defence and security, politics, and religion.

#### Conditions for establishment of a foreigninvested pre-school:

#### 1. Investment capital

1. Minimum of 30 million VND per child (excluding land use cost). Total minimum investment is calculated at the time of fullest capacity. The plan for investment capital must comply with projected scales for each period.

2. For pre-schools renting facilities, the minimum investment per student is 21 million VND.

#### 2. Facilities

1. The school campus must be in one location, in an appropriate environment. The floorplan of the school building is to be calculated based on the number of intended classes and children to be accommodated. The minimum average area constructed is 8m2 per child for urban areas, and 12m2 per child for rural areas.

2. Appropriate rooms for learning, bedrooms for the children, and other rooms with appropriate functional areas; lighting, desks and chairs, equipment and aids used for childcare and teaching; must be provided.

3. Facilities must include a school office: a boardroom/ principal's office; rooms for administration and logistics; a clinic; areas suitable for security and other staff; storage for equipment, materials and aids used for managing, caring for and teaching of children.

4. Appropriate water supply and drainage systems and toilets, while sanitation facilities must be safe. clean and suitable for the operation of the school.

5. The kitchen must be organised based on flow-through principles, and use suitable equipment and materials that ensure food safety and hygiene, if the school caters for the children.

6. A playground and surrounding fence/walls, and a gate specifying the school's name.



7. There must be trees in the school area. All construction, equipment, materials and toys must ensure absolute safety for the children.

#### 3. Curriculum

1. The curriculum to be delivered at a foreigninvested pre-school must demonstrate educational goals, having no contents that: damage Vietnamese national defence, security and public interests; propagate religion, distort history or negatively affect the cultures, ethics and traditional customs of Viet Nam; and must ensure connecting pathways between training levels.

2. Foreign-invested pre-schools may adopt Vietnamese curricula according to Vietnamese laws, or foreign curricula.

3. The Ministry of Education and Training determines compulsory learning content for Vietnamese students studying in foreign invested pre-schools, schools, universities and branch campuses.





#### 4. Academics

1. Teachers must hold at least bằng cao đẳng (associate degrees or higher national diplomas) in early childhood education pedagogy or equivalent.

2. The maximum number of children per class or group is provided for as follows:

For children in kindergartens:

- From 3 12 months old: 15 children per group.
- From 13 24 months old: 20 children per group.
- From 25 36 months old: 25 children per group.

For children in pre-schools:

- From 3 4 years old: 25 children per class.
- From 4 5 years old: 30 children per class.
- From 5 6 years old: 35 children per class.

3. The number of teachers within one group or class is provided for as follows:

• For children in kindergartens: five children per teacher.

• For children in pre-schools: ten to 12 children per teacher.

1. The school proposed for establishment must conform with the education institution network approved by a competent authority.

2. Investment in education must comply with the laws of Viet Nam and international treaties to which Viet Nam is a signatory.

3. Investment can be made in the disciplines, subject to current regulations, with the exception of those in national defence and security, politics, and religion.

#### Conditions for establishment of a foreigninvested school:

#### 1. Investment capital

1. Minimum of 50 million VND per student (excluding land use cost). Total minimum investment is calculated at the time of fullest capacity, but no less than 50 billion VND.

2. For schools renting facilities, the minimum investment per student is 35 million VND.

#### 2. Facilities

1. The school campus must be in one location, in an appropriate environment. The floorplan of the school building is to be calculated based on the number of intended classes and children to be accommodated. The minimum average area constructed is 6m2 per child for urban areas, and 10m<sup>2</sup> per child for rural areas.

2. The average area for learning and teaching: at least 2.5 m2 per student.

3. Appropriate offices for the board of principals and teachers, and appropriate meeting rooms.

4. Subject classrooms (for middle schools and high schools), library, desks, chairs, teaching equipment and aids that satisfy the current standards of the Ministry of Education and Training.

5. Multi-purpose gyms, art rooms, computer labs, supporting rooms for disabled students and school clinics; canteens and break rooms (for day-boarding schools).

6. Clean water supply and drainage systems, and toilets suitable for the scale of the school, meeting current standards of the Ministry of Education and Training.

7. Playground, training grounds, and a parking lot that accounts for at least 30% of the school lot area. The school must be surrounded by fence/walls with gates specifying the school's name.

#### 3. Curriculum

1. The curriculum to be delivered at a foreigninvested school must demonstrate educational goals, having no contents that: damage Vietnamese national defence, security and public interests; propagate religion, distort history or negatively affect the cultures, ethics and traditional customs of Viet Nam; and must ensure connecting pathways between training levels.

2. Foreign-invested schools may adopt Vietnamese curricula according to Vietnamese laws, or foreign curricula.

3. The Ministry of Education and Training determines the compulsory learning contents for Vietnamese students studying in foreign invested pre-schools, schools, universities and branch campuses.

#### 4. Academics

1. Teachers must hold at least a bachelor degree in pedagogy or equivalent.

2. The number of teachers must ensure at least a ratio of 1.5 teachers per class for elementary schools; 1.95 teachers per class for middle schools; and 2.25 teachers per class for high schools.

3. The number of students must not exceed 30 per class for elementary schools; 35 per class for middle and high schools.

#### APPLICATION FOR THE INVESTMENT LICENCE

**Licensing Authority:** Ministry of Planning and Investment

An application for an investment licence is submitted to the Department of Planning and Investment where the proposed university is located, which will review the application then submit it to the Ministry of Planning and Investment. The Ministry of Planning and Investment will then consult with the Ministry of Education and Training before submitting it to the Prime Minister for consideration and approval. All these procedures are subject to the Investment Law of Viet Nam.

#### Educational conditions for issuance of the investment licence:

1. The university proposed to be established must conform with the education institution network approved by a competent authority.

2. Investment in education must comply with the laws of Viet Nam and international treaties to which Viet Nam is a signatory.

3. Investment can be made in the disciplines, subject to current regulations, with the exception of those in national defence and security, politics, and religion.

Conditions for establishment of a foreign-invested university:

#### 1. Investment capital

1. New foreign-invested university (new construction): VND1,000 billion (~US\$44 million), excluding land cost.

2. New foreign-invested university (facilities rent or contributed by Vietnamese partners): VND700 billion (~US\$31 million).

3. Branch campus of a foreign-invested university: VND250 billion (~US\$11 million).

#### 4. Foreign-invested university established as a

branch campus of a foreign university: VND500 (~US\$22 million).

#### 2. Facilities

1. The land area for construction of the university must be at least  $25m^2$  per student at the time of full capacity.

2. The average constructed area must be at least 9m<sup>2</sup> per student, of which at least 6m<sup>2</sup> per student must be dedicated for learning and at least 3m<sup>2</sup> per student must be dedicated for student living.

3. Adequate lecture halls, classrooms and functional rooms that satisfy the training requirements in the appropriate disciplines and forms of training.

4. Adequate offices, administration areas, and managing boards that suit the organisational structure of the relevant academic departments, faculties and disciplines. The minimum area must be 8m<sup>2</sup> per person.

5. Conference rooms, libraries, testing labs, worshops and other facilities that satisfy the requirements of the training programme and science- and technology-related activities.

6. Canteens and construction works serving recreation, sports and cultural activities, and medical constructions and services serving the managers, lecturers, and students.

7. A technical construction area and vehicle parking spaces.

#### 3. Curriculum

1. The curriculum to be delivered at a foreigninvested educational institution must demonstrate educational goals, having no contents that: damage Vietnamese national defence, security and public interests; propagate religion, distort history or negatively affect the cultures, ethics and traditional customs of Viet Nam; and must ensure connecting pathways between training levels.



2. Foreign-invested universities may adopt Vietnamese curricula according to Vietnamese laws, or foreign curricula.

3. The Ministry of Education and Training determines the compulsory learning contents for Vietnamese students studying in foreign invested pre-schools, schools, universities and branch campuses.

#### 4. Academics

1. Lecturers must hold at least a master's degrees or higher. The proportion of lecturers that hold doctorate degrees must not be lower than 50% of the total lecturers, except for some particular disciplines to be considered and approved by the Minister of Education and Training.

2. The maximum ratio of students to lecturers is 10:1, applicable to arts majors; 15:1 applicable to science and technology majors; 25:1, applicable to

social sciences, humanities and economics majors, and business administration majors.

3. Adequate permanent lecturers to undertake at least 60% of the programme load of each discipline.

4. Foreign lecturers teaching at a foreign-invested educational institution must be experienced in the discipline that they teach, except for cases stipulated in point e of this clause.

5. Native speakers teaching language skills must hold at least a bachelor's degree or higher and a suitable foreign language teaching certificate.

1. An application for approval of establishment.

2. A certified true copy, or a copy enclosed with an original, of the Investment Licence.

4. A certified true copy, or a copy enclosed with an original, of the approval of land lease by the Provincial People's Committee for new construction, or an agreement in principle of land lease or available facilities and relevant legal documents.

5. A detailed plan for facilities or a detailed projection on investment in building facilities, including both description and detailed design of the university.

6. A proof of financial capacity as prescribed.

#### **Procedures:**

One set of the documents listed above is submitted by hand or by post to MOET.

1. Within five working days upon receipt of complete documents, the application receiving agency will check the documents and send them to relevant agencies and units for their opinions.

2. If the documents are incomplete, within five working days, the application receiving agency will notify the applicant by writing either directly or by post or by email.

3. Within ten working days upon receipt of the letter of request, the relevant agencies or units must respond in writing.

4. Within 30 working days upon receipt of complete documents, the application receiving agency will prepare an appraisal report and submit it to the Minister of Education and Training for consideration and approval of the submission to the Prime Minister for the decision of establishment of the university.

5. If the application is rejected, within five working days upon receipt of the opinion of the Prime Minister, MOET will notify the applicant in writing either directly or by post, specifying clearly the reasons for rejection.

#### Approval process for the establishment of a representative office of a foreign education institution

#### Who can establish a foreign educational representative office in Vietnam?

A foreign educational institution can establish a foreign education representative office in Viet Nam if it:


1. Has a legal status.

2. Has been operating for at least five years in the home country; and has been accredited or recognized for its education quality by a competent agency.

3. Has clear charters, principles and targets.

4. Has regulations on organisation and operation of the representative office being established in Viet Nam that conform to Viet Nam's laws; and

5. Has a location for the representative office and can ensure security, labour safety and hygiene as prescribed by the laws of Viet Nam.





#### What are representative offices permitted to do?

1. Contact and boost cooperation between the educational institution that it represents and the Vietnamese educational institutions through the promotion of joint educational programmes and projects.

2. Organise exchange activities, consultations, information exchanges, seminars, and exhibitions on education, that aim to introduce the foreign educational institution that it represents.

3. Expedite and supervise the implementation of the agreements on educational cooperation signed with Vietnamese educational institutions.

4. Must not engage in educational activities that directly generate profit in Viet Nam, and must not establish branches under it.

5. Before November 30 every year, the representative office must send a written report about its operations to the Department of Education and Training of the province where it is located; also, if requested by the competent agency, it must provide documents and information regarding relevant problems. The report must be submitted online or in writing.

6. Fulfil other obligations as prescribed by the laws of Viet Nam.

In the event of rejection, MOET will notify the applicant in writing, specifying clearly the reasons for rejection

2. If the documents are incomplete, within five working days, MOET will notify the applicant by writing either directly or by post or by email.



#### **REGISTRATION FOR OPERATION**

#### Licensing authority:

Department of Education and Training (DOET)

#### **Essential documents required:**

1. An application for approval for operation of the representative office.

2. A certified true copy, or a copy enclosed with an original, of the decision on approving the establishment of the representative office, and copies of the application documents already submitted to the Ministry of Education and Training to request for the aforesaid decision.

3. The decision on the appointment of the manager for the representative office and his/her resume.

4. The personnel of the representative office and their resumes.



#### Procedures:

One set of the documents listed above is submitted to DOET where the representative office is located within 20 working days from the effective date of the decision of establishment of the representative office.

1. Within ten working days upon receipt of complete documents, the director of DOET will issue a certificate of operation registration and publicise it on DOET's website. In the event of rejection, DOET will notify the applicant in writing, specifying clearly the reasons for rejection.

2. If the documents are incomplete, within five working days, DOET will notify the applicant by writing either directly or by post or by email.





#### AMENDMENTS AND EXTENSION OF THE ESTABLISHMENT LICENCE

Licensing Authority: Ministry of Education and Training (MOET)

The foreign education institution must apply for amendments, modifications or extensions of the establishment licence of its representative office in the following cases:

1. Change of name, the head, or headquarters of the foreign education institution in its home country.

2. Change of name, manager, or location of its representative office in Viet Nam.

3. Upon the expiry of the establishment licence of its representative office.


#### **Essential documents required:**

1. An application of the foreign educational institution with clear information and explanation of any amendments, supplements and extensions of the establishment licence of the representative office.

2. The original or a copy of the establishment licence of the representative office.

3. The registration certificate of the representative office, or a copy if it has already registered for operation.

4. A detailed report on the operation of the representative office.



#### **Procedures:**

A set of the documents listed above is submitted to MOET by hand or by post within the six months before the expiry of the establishment of the representative office.

1. Within 20 working days upon receipt of complete documents, MOET will appraise the application and issue a decision of renewal or modification of the representative office if all requirements are met. In the event of rejection, MOET will notify the applicant in writing, specifying clearly the reasons for rejection

2. If the documents are incomplete, within five working days, MOET will notify the applicant by writing either directly or by post or by email.



#### TERMINATION OF OPERATION OF THE REPRESENTATIVE OFFICE

#### Authority:

Ministry of Education and Training (MOET)

Operation of representative offices is terminated in the following cases:

1. The establishment licence expires.

2. Upon the request by the foreign education institution who set up the representative office.

3. The establishment licence is revoked because the representative office fails to operate within six months from the effective date of the first establishment licence or within three months from the effective date of the renewed establishment licence.

4. Fraud is discovered in the application documents for the establishment licence.

5. Engagement in activities in contravention of the establishment licence is discovered.

6. Breaches of other Vietnamese laws or regulations.



#### **Essential documents required:**

1. An application for approval of operation termination of the representative office, clearly specifying the reasons for termination.

2. A detailed plan for terminating the operation with clear measures for ensuring the legal rights of the employees; a plan on resolving any outstanding financial or property matters.

#### Procedures:

One set of the documents listed above is submitted to MOET by hand or by post.

1. Within 20 working days upon receipt of complete documents for termination of the representative office, MOET will consider and make appropriate decisions. If the documents are incomplete, MOET will notify the applicant in writing

2. If the representative office is in breach as stated in points 3 to 6 above, MOET will inspect and make appropriate decisions.





# 6 Conclusions and potential for cooperation

Education has always been the national top priority, not only of the whole political system but also of parents. Traditionally, Vietnamese parents have always had an ardent desire to invest in their children. They are prepared to work hard day and night and save for their children to go to school and then college, because they have a strong belief that only education can help their children have a better future. According to the General Statistics Office, parents are paying more and more for their children to study. The average household expenditure on education and training for one learner in 2020 was over 1.7 times (VND7,075,000) that of 2012 (VND4,082,000).

Realising the importance of the internationalisation of education as a current global trend, the Government of Viet Nam has issued a number of policies, facilitating and enabling foreign cooperation and investment in education. "Development of high-quality human resources to meet the demand of the Fourth Industrial Revolution and international integration" is one of the ten key tasks that the Government has set out in Resolution No. 50/NQ-CP, to implement the Resolutions of the Thirteenth National Party Congress.

The demand for quality education and training is high from both parents and students themselves, and equally the desire of the Government of Viet Nam for the development of the country. However, the supply of quality education is limited. This has given ample opportunities for foreign individuals and institutions to invest in the education sector in Viet Nam.

Despite the strict conditions for cooperation and investment in educational subjects to the regulations of Decree 86 - and to other legal documents for the purposes of quality assurance, which are under revision for better accommodation of real-life practice- central and local governments in Viet Nam have already put incentives in place, and it is advisable for foreign investors to study these incentives carefully.
