

Intended Learning Outcomes of Phase II

For Teaching staff:

• To understand what makes good teaching and demonstrate up to date skills in planning and delivering effective and engaging teaching sessions

• Be equipped with the skills to implement new ways of teaching and conducting assessment in order to enhance the student learning experience and student outcomes

• Be able to evaluate the effectiveness of changes in their professional practice.

For Administrative staff:

• To have a raised awareness of change management strategies and tactics and understood how to apply these to their organizational situation

• To have understood trade-offs and impacts of strategic decisionmaking around improving the student experience, including from multiple stakeholder perspectives
